I. Data controller

Your personal data is processed for the purposes of fulfilling the legal obligations of the data controller (managing obligatory trainings and monitoring whether occupational safety/security rules are implemented at event venues), ensuring the legitimate interests of the data controller (preserving camera recordings to ensure the security of physical locations, detecting and investigating breaches in workplace rules), your explicit consent (sharing your photos or name on social media platforms), and in cases explicitly stated in law (processing internet traffic logs as per Law No. 5651).

IV. Our Purposes for Processing Personal Data

Your abovementioned personal data shall be processed for the fulfillment of the purposes below that are subject to your transfer of the said data to us:

- Event and organization management
- Creating and monitoring visitor records
- Organizing event venues, identifying participants, analyzing attendees, creating statistics for following events, printing ID cards or participant lists
- Ensuring the safety of physical locations
- Planning and executing the company's information security processes,
- Planning and executing visitors' access to information
- Informing authorized persons, entities and institutions,
- Conducting social responsibility and civil society activities
- Managing relations with business partners, service providers and suppliers
- Conducting training activities
- Contacting participants before and after the event
- Receiving feedback from speakers about the event
- Creating a participant portfolio, evaluating statistical figures on participation in the organized event
- Providing information on programs, events, offers and all training processes and creating bulletins,
- Managing emergency management processes,
- Managing activities related to Occupational Health and Security
- Contacting stakeholders with regard to events that will be held in the future

V. Transferring Personal Data

In line with the "need to know" and "need to use" principles, our Company strives to process your personal data by ensuring the necessary data minimization and taking the required technical and administrative security measures. We are obligated to share the personal data we process with third parties for a specific set of purposes, since activities such as managing event organization processes, managing a digital infrastructure require a constant stream of data transfer with various stakeholders.

In order to solely fulfill the abovementioned purposes, your personal data may be shared with our shareholders, business partners, subsidiaries and affiliates, holding companies, the companies and shareholders of **SNI BİLİŞİM TEKNOLOJİ SANAYİ VE TİCARET A.Ş.** with which we have a special business partnership for conducting business continuity and information security processes, as well as with our business partners and service providers that run provide, operate, or offer services for our IT infrastructure, our business partners and services providers that offer quality control, complaint management, and risk analysis services, legally authorized public institutions, private persons, organizations and third parties, and exclusively designated third parties in line with the legitimate interests of the data controller, in accordance with the purposes specified in this disclosure statement, and may be processed domestically or internationally. In addition, personal data may be shared with the following parties:

- Third parties such as event venue owner, event business partners, sponsors and security companies in order to ensure security throughout the event (data shared: ID information and camera recordings)
- Service providers for the purpose of fulfilling payment obligations and managing accounting activities
- Advertising, promotion and social media business partners in order to promote the event or the Company, provide information, and conduct advertising activities
- Domestic and international service providers for travel, transport, accommodation and event management activities within the scope of planning and executing such activities
- Law enforcement officials due to legal requirements as to entrance/exit to and from the event venue (data shared: ID and contact information)
- Prosecutor's Office, courts or law enforcement in the event that log records and camera recordings are requested by public authorities.
