

## Saudi Arabia e-Invoicing



#### Who is under the scope?

- 1. The taxable person residing in the Kingdom. (Resident Taxpayers)
- 2. The customer or any third party who issues a tax invoice on behalf of the resident taxpayer
- 3. In the first wave taxpayers who the revenue subject to VAT for the year of 2021 exceeding 3 billion SAR.

### What is the scope?

Mandatory B2B and B2C electronic invoice generation, archiving and sending to the tax authority's portal

### Which documents?


All tax invoices, simplified tax invoices, credit and debit notes issued under VAT regime

- Standard Tax invoice (B2B)
- Simplified tax invoice (B2C)

### What are the conditions to store e-invoices?

Electronic invoices must be archived 6 years in a local server or in the cloud and can be stored outside of KSA.

### **Standard Tax Invoice**






- Business-to Business(B2B) Transactions
- Clearance model
- Signed by ZATCA
- Contains all elements of an invoice
- VAT number of the buyer mandatory
- Adding QR code is mandatory after Phase 2

### **Simplified Tax Invoice**

Always include all mandatory fields for E-invoice



Business-to Customer(B2C) Transactions

sn

- Invoice reporting
- Signed by the taxpayer
- Sent to ZATCA within 24 hours of issuance
- Contains only main invoice elements
- QR code is mandatory since Phase 1
- Present hard copy of invoice to the customer is required



## Violations and penalties for Non-compliance e-invoice



- Not issuing and storing e-Invoices in required format
- Modifying or deleting e-Invoices after generation
- Not adding QR code or not working
- Failure to notify ZATCA of the buyer's VAT registration number or any malfunction that prevents the issuance of electronic invoices.
- Including any type of prohibited functions in e-Invoice


